ORDER:

The Commissioner and Director of Municipal Administration, Andhra Pradesh Hyderabad, in reference 3rd read above has informed that in accordance with the orders issued in the references 1st and 2nd read above "Special Grade Municipality means a Municipality with an annual income of Rs. more than 6.00 Crores and less than 8.00 Crores". He has stated that the annual income of the Siddipet Municipality during the financial year 2010 to 2011 is Rs. 1002.22 Lakhs, and requested the Government to upgrade the Siddipet Municipality from Second Grade to Selection Grade Municipality.

2. Government, after careful examination, have decided to upgrade the Siddipet Municipality from Second Grade to Special Grade Municipality as the income criteria, specified in the Andhra Pradesh Municipalities (Gradation of Municipal Council and Nagar Panchayats) Rules, 1995 is fulfilled.
