Urban Development Authorities - Constitution of "Siddipet Urban Development Authority" - Notification - Orders - Issued.

ORDER: -

Whereas, Government have constituted Urban Development Authorities for major towns and cities of the State. The provisions of the Telangana Urban Areas (Development) Act, 1975 (Act-1 of 1975) are being invoked for the requirement of preparing master plan, enforcing zoning regulations and integrated planning and regulating developments in a planned manner and now it is decided to extend these provisions to many other areas of the State, even though all such areas may not be a large urban population or may not have in the vicinity of large cities. One such area, which requires special attention is Siddipet Town and its immediate surroundings situated in Siddipet District.

2. And whereas, to achieve the above objectives and to develop the Siddipet Town and its immediate surrounding areas, Government in exercise of the powers conferred by sub-section (1) of Section 13 and sub-section (1) of Section 3 of Telangana Urban Areas (Development) Act 1975, hereby declare a 'Development Area' for Siddipet Town and its immediate surroundings in Siddipet District consisting of Siddipet town and (21) adjoining villages in Siddipet District as specified in the Notification-I annexed to this G.O. and named as "Siddipet Urban Development Authority" and constitute the Authority for the same as specified in the Notification-II annexed to this G.O.

3. The appended notifications shall be published in the Extraordinary issue of the Telangana Gazette Dated:06-11-2017.

4. The Commissioner of Printing, Stationery and Stores Purchase, Hyderabad is requested to supply 100 copies of the Extraordinary issue of the Telangana Gazette.


